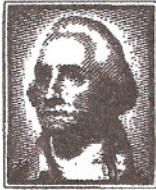
Be It Further Resolved, That a duly authenticated copy of this resolution, signed by the President and attested by the Secretary, be transmitted to the American International School System.

Dear Dr. Kazmir,

I would like to take this opportunity to commend and congratulate you and the staff and management of American International School System on the establishment of your new school in Lahore, Pakistan.

I have seen pictures of the school, read your prospectus and mission statements and spoken to our representatives in the area. I am impressed by the magnitude and current success of this undertaking.

Pakistan has a population of approximately 165 million people, nearly 40% of whom are under 15 years of age. The curriculum of AISS is modeled on curricula in use in the U.S. rather than on traditional curricula commonly used in Pakistan. AISS is providing an alternative world-class education that will help the children of Pakistan become more prosperous, secure and democratic, and therefore less likely to support violence or extremism of any kind.
